Please review and initial each term and condition of the sale below. By initialing, you acknowledge that each item has been thoroughly reviewed with you by your sales representative.

### PRICES AND PAYMENT TERMS:

- \_\_\_\_\_ Upon ordering, either the special cabinetry dollar total or a 50%, non-refundable deposit is due, whichever is more. No orders will be made without a deposit. Payment can be made in the form of a credit card, check, cash or money order.
- \_\_\_\_\_ For all leased orders, upon ordering, customer agrees to authorize their lease company to administer a 50% deposit made payable to Belvedere USA Corporation. No orders will be entered without a 50% deposit from the lease company.
- \_\_\_\_\_ Remaining balance is due upon order completion. An estimated due date will be provided at the time of order entry and a final notification letter will be sent to you up to 15 days before completion date. All final payments must be in the form of a credit card, certified check or money order. For leased orders, client agrees to accept merchandise at the time of completion per the written Storage Agreement. At this time, payment is due to Belvedere USA Corporation from the lease company. Once final payment is received, your order will ship direct to the place of storage specified on the Storage Agreement. If payment is not made at time of completion date, deposit will be forfeited and the order will be cancelled.

### ORDER INFORMATION, CHANGES AND CANCELLATIONS:

- \_\_\_\_\_ Changes and cancellations will be subject to fees based upon the degree of completion of the manufactured product. For standard product with standard lead time:
- Within 5 weeks of original due date...20% of product selling price
  - Within 4 weeks of original due date...40% of product selling price
  - Within 3 weeks of original due date...60% of product selling price
  - Within 2 weeks of original due date...80% of product selling price
  - Within 1 week of original due date...100% of product selling price
- For specials either - "No cancellations will be accepted once the order is signed" or "Changes will be subject to fees based upon impact and the degree of completion";
- Within 6-8 weeks of original due date...50% of product selling price
  - Within 3-5 weeks of original due date...75% of product selling price
  - Within 0-2 weeks of original due date...100% of product selling price

Major changes such as color/finish, style, etc., of cabinets will be held to the same fee as above. Minor changes, such as knob style, cash drawer placement, tool holder location, hardware, etc., will be charged according to the effect on product and schedule.

- \_\_\_\_\_ Customer is responsible for any and all additional charges related to changes/cancellations that occur after 3 business days from order entry.

## WARRANTY

The Company warrants its products to be free from defects in material and workmanship for the periods listed below (except misuse or mishandling) from the date of delivery to the customer. The Company's obligation and purchaser's remedy pursuant to this warranty are limited to repair or replacement at the company's option. F. O. B. shipping point. Because commercial standards allow color variation over which the Company has no control, this warranty does not extend to color, grain or texture. Fabrics are not warranted against fading, staining, soiling, crushing or wear, all of which are predominately influenced by user-created environment and user care to which the product is exposed in use. Petroleum-based cleaning solvents are harmful to fabrics and their use will void the warranty. This warranty applies only to the shop or salon originally purchasing from an authorized Company distributor. Claims should be made through the authorized distributor from whom the equipment was purchased. Belvedere has the right to request photographs or other objective evidence in determining warranty application.

- 1 year on chair, upholstery, laminates, plastic, metal and wood parts
